What is the overall deductible?	\$1,000.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible?	Yes. Preventive care services are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. For prescription drug services: \$500 individual / Not applicable family. There are no other specific deductibles . What is the out-of-pocket limit for this plan?	For In-Network providers \$3,000. For Out-of-Network providers \$6,000.	The out-of-pocket limit is the most you could pay in a year for covered services.
